### **DESCRIPTION**

Liquid cleaner with **acidic content** to remove residues such as cementitious mortars, paint, gypsum, tile grout, from the surfaces which are resistant to acids.

# **APPLICATION AREAS**

- Indoor and outdoor
- Horizontal and vertical surfaces
- Cleaning tiles, ceramics, granite ceramics, clinker, terra cotta, rustic coverings, matte natural stone and cast stone surfaces after the application,
- Abrasive because of its acidic content. Should not be used on natural granite, marble, natural stone or specially glazed mosaic coverings and metals as it may cause loss of brightness.

# PREPARATION OF THE SURFACE

Since the material has an acidic structure, check the resistance of the surface to acid before the application by making a test in a small area. Otherwise the coating may be damaged.

- Dilute the product 1/1 to 1/3 with water depending on the amount of residue.
- When diluting, add the product to the water since the product has an acidic structure. Do not add water on the product.
- Pour FİXA Cement Residue Remover onto the cement residue and rub until the cement residue becomes damp and wet.
- Wait for 5 10 minutes to allow the material adhered to the surface to dissolve.
- Remove the loosened residues from the surface with a plastic construction brush or a damp cloth that will not damage the surface.
- Take the dirty water on the floor into a bucket with a sponge.
- · Rinse the surface with water.

#### **CAUTION**

- Use acid resistant gloves.
- Do not use on non-acid resistant coating materials, polished and buffed surfaces and polished marble and granite surfaces. If necessary test on a narrow area.
- Do not use to clean oil.
- Do not add other cleaning materials and bleaches into the product.
- Avoid contamination of drinking water and groundwater.
- Avoid contact with cement based tile grouts.

### SHELF LIFE

Expires in 12 months. Store unopened packages in a dry environment. Shake well before use. Protect against freezing.

### **HEALTH AND SAFETY**

As with all chemical products, avoid contact with food, skin, eyes and mouth during use and storage. In case of contact immediately wash with plenty of water and soap. If accidentally swallowed, drink water, do not try to neutralise and immediately consult a doctor. Do not induce vomitting. During the application, use work clothes, protective gloves and glasses in accordance with the occupational and worker health rules. Avoid contact with food and drinks, ventilate application area. Store out of the reach of children.
