DESCRIPTION

Liquid cleaner with base content to remove stains such as oil, coffee, tea from covering materials.

APPLICATION AREAS

- Indoor and outdoor
- Horizontal and vertical surfaces
- Glossy or matte surfaces
- Parquet and laminated parquet floors

 Removing stubborn stains such as oil, coffee, tea, ink, wine and fruit juices from covering materials, such as ceramic, granite ceramic, clinker, cotto, natural stone, marble and granite.

CONSUMPTION

Varies depending on the amount of residues on the surface. 20 - 100 m² of surface can be cleaned with 1 L product.

APPLICATION

- Wipe the surface with a wet cloth before application.
- Depending on the amount of stain, dilute the product with water at a ratio of 1/1 to 1/5. Diluted product can be applied to the surface in 2 ways:

Manual Cleaning: Spread FİXA Stain Remover with a brush over a 2 m² area to be cleaned. Wait 2 - 3 minutes for the product to penetrate the surface and wipe off the dirty liquid on the surface with a cloth. After the entire area is cleaned, if necessary, apply a second coat of FİXA Stain Remover by diluting it with less water and spread it directly on the stains and dirt. Wipe the surface with water again and rinse.

Cleaning with the Machine: Spread FİXA Stain Remover with a brush over a 4 m² area to be cleaned. Wait for 2 - 3 minutes to allow the product to penetrate the surface and wipe off the dirty liquid on the surface by rubbing with the machine. After the entire area is cleaned, if necessary, apply a second coat of FİXA Stain Remover by diluting it with less water and spread it directly on the stains and dirt. Wipe the surface with water again and rinse.

CAUTION

- Use gloves.
- Do not use on laminate flooring, unglazed ceramics, unpolished parquet surfaces and glass surfaces without diluting with water.
- Do not use on aluminum surfaces or objects.
- Do not add other cleaning materials and bleaches into the product.
- Avoid contamination of drinking water and groundwater.

SHELF LIFE

Expires in 12 months. Store unopened packages in a dry environment. Shake well before use. Protect against freezing.

HEALTH AND SAFETY
